
HOWDEN TRADERS CHRISTMAS RAFFLE

VACANCY FOR A TOWN COUNCILLOR

There is a vacancy on Howden Town Council caused by the resignation of a Councillor.

If you are interested in what being a councillor entails, visit the website at <u>www.howden-tc.gov.uk</u> where you will find reports and minutes of meetings describing the range of the council's activities. Meetings of the council and its committees are open to the public to attend, and the details are posted on the website and on the noticeboard outside the Shire Hall in Market Place a week ahead of each meeting.

The full council meets on the evening of the third Tuesday every month, and there may be special meetings called from time to time. Councillors are also required to serve on other committees such as Planning, Amenities, Resources and Asset Management, and Burials. So typically a councillor will be required to attend approximately 30 evening meetings a year. In addition councillors are involved 'on the ground' helping with things like public events (such as Remembrance Sunday, or Christmas late night shopping), maintenance jobs at Howden Marsh Local Nature Reserve, emergency assistance (for example with flooding), putting up the Christmas lights and representing the council on other local organisations - to name but a few!

An important principle that this council has adhered to historically is that it is not governed by party politics.

To be eligible you must be 18 years of age or more and a citizen of Great Britain, the Commonwealth, the Republic of Ireland or another Member State of the European Union, and either:

1. Be registered as a local government elector in Howden.

2. Occupied as owner or tenant any land or premises in Howden during the whole of the preceding 12 months.

3. Your principal or only place of work during the preceding 12 months has been in Howden.

4. Have lived in Howden (or within 3 miles of it) during the whole of the preceding 12 months.

You may be disqualified from standing if you:

1. Hold a paid office with Howden Town Council.

2. Are subject to a bankruptcy restrictions order or interim order.

3. Have been sentenced to a term of imprisonment (whether suspended or not) of not less than three months without the option of a fine, during the five years preceding the election.

4. Are subject to any enactment relating to corrupt or illegal practices.

THE ASHES PLAYING FIELD TRUST

Since the public launch of the Ashes Development Plan in April 2016 the Trustees have been working to acquire grants and raise money to make the development plans a reality. The development is a long-term project which we hope can be completed in time for our centenary in 2027 using an incremental approach based on several grant applications and our own fund raising efforts.

Since April the park has already seen numerous small improvements - improved greens at the Bowling Club, the installation of a new 'roundabout' in the Daphne D'Ark Play Park for the children which will accommodate a wheel chair and thus make our play area inclusive for all, much needed maintenance to some ageing trees and new tarmac improving the main pathway through the park. Almost £100,000 has been raised and spent in 2016 to fund these improvements. Over the coming weeks new noticeboards will appear on the groundsman's shed where information will be displayed to keep everyone informed of matters relating to the park, the foundations of the old pavilion will be removed so top soil and seeding can take place to prepare it for use and development and new swings for the 'tiny tots' will be installed.

Plans and funding for major improvements to the drainage of the large field, the Treeton Road entrance and the creation of a wonderful outdoor performance space are currently under investigation.

As a charity run park where all the Trustees are volunteers, raising money through grants and fundraising is key to future development. Once again in 2016 The Ashes are grateful to Howden Town Council for providing them with an annual grant that supports park maintenance.

Business Friends are local firms who want to give something back to their community and are willing to sponsor our events and activities.




THE ASHES IS CELEBRATING 90 YEARS IN 2017

HOWDEN METHODIST CHURCH

Our New Cross

In 2014 I met a lady that changed my life. Her name was Anne Heald. She was the very thin pale looking lady that welcomed me when I first entered Howden Methodist Church in that same year. As soon as she spoke, I knew I had made a friend. Warmth oozed from her. We soon became firm friends and shared a lot of thoughts about the church and the services. Her illness took hold of her later that year and she became unable to come to the church. I visited her weekly (as did about four other people from the church) and we spoke about garage doors (we mended them), walls with peeling paint (we repainted them), plants in the wrong place in the garden (we moved them). Anne & I liked *doing* things together. I went on holiday that year, and Anne looked at me squarely and said, 'I will not be here when you get back.' I tried to pooh-pooh the notion, but sadly she was right. In her will, she left some money for a cross to be put on the church. Anne and I had discussed this earlier, and she was right. If you drive down Hailgate toward the Police Station, you get to a point where the road bends and the church is obscured by a garage. Even at 20mph, blink and you have gone past. Coming back from the Police Station and the name of the building is inconveniently facing the direction you are travelling in. Doh! Missed it again. Visitors often cruised up and down Hailgate and in the end resorted to ringing someone to report, 'I can't find the church'. With a four figure sum to spend, the church decided we needed a big cross so that people would notice it. I like to think that in a way Anne helped me build it.

The cross is 1500mm high and 750 mm wide. I tried cutting perspex with a hack saw. Don't try it. It takes hours to cut 5mm thick stuff and you just end up with a lot of blunt blades. So off to a specialist firm the perspex went for cutting on a computer controlled machine. *Not* cheap. Everything appeared to go very well until I went to fit it. Both rooms in the church near the cross location do not have power sockets. My wife 'bless her' said 'well it is lit by LEDs so run it on batteries.' Sorry, I should have mentioned that the cross is illuminated. So 12-volt supply. Hold on; it has to have a time clock as its planning permission specifies the times it can be lit. Boating bits catalogue to find 12-volt timer. Rightly or wrongly decided to run the lighting on high capacity AA cells. Charge them four at a time? Forget it there are twenty batteries, far too tedious. Search for a charger that does charging ten batteries at one go. Got one. SO one problem followed another. Days, weeks passed. Not to worry we cracked all the problems and the fit date is now the first week in October. So by the time you read this, it SHOULD be there. I think the church might need to pray a bit about this as it hasn't been plain sailing up to now. Wish us luck dear reader; I think we are going to need it.

Photo Notes:

I. There is a voltmeter on the door of the battery box so a check can be made of its state of charge and also a small window so you can see if the cross is lit or not.

2. The assembled cross lying on our table at home.

3. Open the battery box door and there is a small LED strip. Without going outside, you can set the colour and the intensity of the lights. I tried it flashing RED, but the wife said that was the wrong message to give out. So it's very pale blue and a medium brightness setting as the perspex does not let that much light through it.

4. My artist impression [sent to the town planners]. It's a one-off project. The blue background isn't quite right (the actual background is more a royal blue) and it's not shown far enough up the wall. A parked van will obscure it, defeating the object. So the cross top will line up with the top window line.

If you would like something similar for your garden, please contact me. I would not make another one of these for all the tea in China but I'm quite happy to advise you how to do it.
