# 2023-69-FC: Ashes Committee. To receive the latest minutes and receive report from the Chair.

New Chair of the Ashes Playing Fields Committee, Liz Brant, reported to Council they had held their AGM the evening before and elected new members. There have been some problems on the Ashes Committee and several members resigning, but she was in talks with the Charity Commission who are helping with the process moving forwards. It was agreed by Council to not elect any more Town Representatives to the Committee until such time Council deemed the issues on the Committee have been resolved and this would be looked at in the future.

### 2023-70-FC: Election Update. To receive a report from the Clerk.

The Clerk reported that out of 13 seats there had been 11 confirmed nominees – meaning all nominees would be elected unopposed. There would be a need for co-option which will be agreed at the May meeting.

### 2023-71-FC: Boom Update. To receive a report from the Chair.

The Chair reported the statutory consultation dates had been released and would run from May 9<sup>th</sup> to June 20<sup>th</sup>. A online meeting date has been agreed for Councillors, with online webinars for members of the public organised and four in-person events booked.
